95/08/17 **PLANNING MATTERS**

a) **S/2017/1796/ FUL Paulerspury C of E Primary School. Paulerspury C of E Primary School High Street Paulerspury NN12 7NA**

Variation of condition 2 (plans) of planning permission S/2016/1271/FUL (Replace wooden shed with 20ft x 9ft mobile office) To allow changes to window arrangements.

The original application - S/2016/1271/FUL - showed the windows to be on the side elevations and not facing Tews End Lane. Paulerspury Parish Council would ask that this be the case in this instance in order that there is no adverse effect caused to the residents opposite due to the reflection of the sun via the windows, as is the current case.

b) **S/2017/1769/FUL Mr & Mrs Steve and Julie Blewett 15 Lumber Lane Paulerspury**

Demolition of existing dwelling as approved under application reference: S/2015/2365/FUL.
Proposed replacement dwelling and change of land use from agricultural to residential.

A minor part of the dwelling extends beyond the current Village Confines. Paulerspury Parish Council has consistently objected to any part of new development being outside current Confines.

Under current local planning policy we do object to the change of land use from agricultural to residential.

The proposal could be classed as over- development of the site when compared to the original approved application for this site (4 bedrooms and 2 garages).
