## 170/12/13 TO APPROVE AND SIGN THE MINUTES OF 28 NOVEMBER 2013

Following an amendment to 158/11/13 a) - Mrs Sawbridge and Dr Hooker abstained from comment and voting - the minutes were approved and signed as correct.

Church Hill footpath to be cleared of vegetation.

## 172/12/13 MEMBERS OF THE PUBLIC AND PRESS

Two members of the public were present and County Councillor Mr Walker and District Councillor Mrs Barnes.

Mrs Barnes reported that there had been a considerable number of objections to the proposed planning application for Tews End Lane. Northamptonshire Highways had written a very detailed report strongly objecting to the access proposals.

Concerns were raised about the lack of protection for Paulerspury's Hollow Ways. With a view to registration the clerk would contact the Heritage Officer at South Northamptonshire Council (SNC)for further guidance on this matter. Mr Batten would also research Hollow Ways via the Victorian County History series – Northamptonshire.

Mr Walker reported that Northamptonshire County Council was looking for savings of £38M over the forthcoming 5 years. A 1.99% rise in Council Tax had been proposed which equated to a £30.00 per year rise on a Band D property. Savings would be gained through greater efficiencies, no front line services would be cut.

## 173/12/13 PLANNING MATTERS

## a) South Northamptonshire Local Plan.

Following attendance at the briefing meeting Mr Barnes had received a pack from SNC detailing the information required regarding the responses required.
