Two members of the public were present including County Councillor Mr Walker. Apologies were received from District Councillor Mrs Barnes.

Mr Walker reported that the 2017-2018 budget setting procedure for Northamptonshire County Council (NCC) would be completed mid way through January. It would be a 4 year front loaded budget with cuts of £140M being sought overall. NCC had met their budget for last year. Council tax would be 1.9% with a further 2% added for Social Service provision (£35M required).

Mr Walker had been re selected as the County Council candidate for the election to be held in 2017.
