51/4/17 **PLANNING MATTERS**

a) S/2017/0849/PA Mrs D Wilkes Normandy Barn High Street Paulerspury

Determination as to whether prior approval is required (under Class Q of Part 3 of the above Order) for the change of use of an agricultural building to 1 No. dwellinghouse (Use Class C3) in respect of: the transport and highways impacts of the development; noise impacts of the development, contamination risks on the site; flooding risks on the site; whether the siting and location of the building makes it impractical or undesirable to change the use; and the design and external appearance of the building.

The access gives cause for concern on this narrow stretch of road. The Parish Council would ask that NHA be consulted.

b) S/2017/0363/FUL Mr S Feven Land adjacent to Little Farm 15 Lower Street Pury End

Change of use of land from agricultural to residential and creation of new driveway and parking spaces for Little Farm

Paulerspury Parish Council **OBJECTED** to this application

The site was outside the Village Confines and was therefore classified as Open Countryside. Residential development would not be in accordance with saved Local Plan policies

Careys Road was very narrow and additional residential development exiting on to Careys Road would be unsuitable.

Should permission be given to this application it could set a precedent to other applications which lie outside the Village Confines.

c) <u>S/2017/0995/FUL</u> Mr Edward and Mrs Joanne Phipps Willow Cottage, 2 Kings Lane Pury End

First Floor side & front extension, replace garage flat roof with pitched roof

Paulerspury Parish Council had **NO OBJECTIONS** to this application.

d) S/2017/0264/FUL 15 Lumber Lane Paulerspury SNC REFUSED

e) S/2017/0395/FUL 8 Careys Road Pury End SNC APPROVED

f) S/0418/FUL Pury Hill Farm Alderton Road Paulerspury SNC APPROVED

g) <u>Local Plan Part 2</u>. Report on the meeting held at South Northamptonshire Council to discuss Part 2. Mr J Barnes

See notes attached to the minutes.

Concerns were raised regarding the impact on Heathencote residents should there be further development of Towcester Race Course, as referred to in the Local Plan Part 2. The proposal referred to a Leisure and Sports Village at Towcester Racecourse. This proposal would allow for the further enhancement of the existing horse/ greyhound racing facilities including Animal Care/ Events/ Leisure uses, including new high quality retail restricted to country sport, food and leisure uses. The Proposal would also allow for sports/ leisure provision including new facilities for sports including for example dedicated gymnastics and squash facilities and a golf driving range and hotel development. This development whilst in Paulerpsury Parish would be outside existing Confines.

Mr Barnes would head up a Working Group to assess current Confines.

h) <u>DESIGN GUIDE SUPPLEMENTARY PLANNING DOCUMENT</u>

South Northamptonshire Council is consulting on a new Design Guide which seeks to update the Council's existing guidance on issues regarding design, heritage, landscape and the built environment within the District.

Mr Bloomfield would be asked to consider this document and respond on behalf of the Parish Council.

i) <u>Gargantuan Northampton Central – Ashfield Land's 'Rail Central' and Roxhill's 'Northampton Gateway'</u> To consider the development proposals both of which are in contravention of the West Northants Joint Core Strategy.

Paulerspury Parish Council would not support this proposed development.

i) No 46 High Street Paulerspury. Response from Mr Smith the Enforcement Officer.

A view would be taken on the overall appearance of the works when the windows have been added.

Local Plan Part 2A: Preferred Options (Part 1 from WNJCS) SNC Briefing Meeting at The Forum, Towcester – 5 April 2017

There will be a formal public 10-week consultation seeking comments on the Local Plan – starting in June 2017. Current draft of the Plan is on the SNC website.

Key Points

- 1. Confines for District's villages have been reviewed by SNC parishes (including Paulerspury) need to let SNC know of any objections before June. Any agreed changes before June will be included in the public consultation.
- 2. Guidelines for defining Local Green Spaces are on SNC Local Plan website. Let SNC know by June of any Paulerspury PC proposals.
- 3. Confines policy is dependent on a positive approach to development in the whole of the District.
- 4. Current intention is that something like the previous IRHP won't be repeated.
- 5. It will be necessary to meet local needs at parish/individual settlement level but there must be robust evidence of need.
- 6. A permissive policy is to be adopted through a "Local Objectively Assessed (housing) Need" [LOAN].
 - a. probably most parishes do not actively want this but such development will depend mostly on the suitability of the site.
 - b. a further aspect of the 'LOAN' approach is that the developer will be expected to work with the local parish.
- 7. Further housing policies would seem to include that 10% of all homes on individual sites should be affordable home-ownership products (for sites of 10 dwellings or more).
- 8. The results of a call for sites in the District are listed on the SNC website by each parish.
