Creation of secondary access track. (Retrospective)

This application appeared to be a retrospective application as a secondary track had already been created which, in its current form, was deemed to be unacceptable.

The Parish Council had now been assured by the applicant that this was a temporary entrance created by the builder to be used during the building process.

The Parish Council did however have concerns about the creation of an additional entrance onto the very narrow Careys Road.

Should an additional entrance be allowed then Paulerspury Parish Council would view a green track as preferable, and more acceptable, in that location.

d) S/2019/0363/FUL Mr S Osborne Land to rear of 1 The Green, Paulerspury

Proposed single dwelling, garage and access.

Paulerspury Parish Council had the following observations regarding the above application:

- 1) Given the location, in the event this application be approved, safety arrangements must be in place to ensure that the public was fully protected when building works were underway.
- 2) Concerns were expressed with regard to potential parking on this stretch of the High Street where it approaches a bend near the church.
- 3) The building line protrudes beyond that of No 61
- 4) The proposed dwelling appears large for the size of the plot.
- 5) Consideration should be given to the design of the shared garage with cars parked in tandem, which may be an issue if either the proposed house or No 1 the Green were to be sold.
- 6) On the plus side, If cars from No 1 The Green were to be parked in the proposed area in future then it would be a great advantage.
- 7. The development would be in keeping with surrounding neighbours.
