Report on the agenda of the Parish Council Thursday 26 March 2020

On Monday 23 March the Government declared that all citizens of the United Kingdom should isolate themselves at home. Life threatening Coronavirus (COVID-19) - was spreading throughout the country so in order to limit contagion and therefore reduce the pressure on the National Health Service all non essential work had to cease, non essential shops would close and people should work from home where possible. Residents would only be allowed out to collect medicines; take a daily walk for exercise; collect groceries or visit an infirm relative. People were instructed to stay 2 metres away from each other at all times. This therefore meant that the council meeting could not take place.

Minutes of the previous meeting had been circulated with no issues being brought to the attention of the council. The accounts were listed in the agenda and these were approved for payment.

One additional action was taken. A group of volunteers had opened a "shop" in Pury End. This was stocked with essentials to help those in need. Prices are listed for the goods on offer. A request was made for a donation to help purchase such as cleaning materials etc. It was agreed that an initial donation would be made of £100.00. This had been done and had been gratefully received

a) <u>S/2020/0282/FUL</u> & S/2020/0283/LBC Mr Cassian Pasqua Heathencote Lodge, Shutlanger Road.

Side extensions to existing dwelling. Internal alterations to include conversion of garage to living accommodation. New car port. Replacement vehicular & pedestrian gate to site entrance. Block up existing gate to west of site.

Paulerspury Parish Council had NO OBJECTIONS to this application.

#### b) S/2020/0306/FUL Mr S Feven Little Farm, Careys Road, Pury End

Detached dwelling incorporating existing garage.

Paulerspury Parish Council strongly OBJECTED to this application.

The site lies outside the village confines and therefore sits within the open countryside. Saved Policy H6 builds on EV2 in that new housing will not normally be permitted in open countryside. No exceptions can be supported in this case. Paulerspury Parish Council has been consistent in opposing new building works outside the village confines – Principle 1 Village Confines and Protected Areas, Paulerspury and Pury End Design Statement.

The West Northamptonshire Joint Core Strategy Policy S1 seeks to limit new development in rural areas. Given the absence of employment, minimal public transport and basic services any residents would have to rely on private vehicles. This application to build in open countryside does not respond to local need and is neither a re use of buildings (newly built garage). This application is for market housing so none of the exceptions in policies relating to specialist housing are relevant.

South Northamptonshire has exceeded its housing land supply so there can be no justification on that basis.

When permission was granted for the garage (S/2018/0928/FUL) the planning officer commented that it was "a sizeable structure" and "would not visually compete with it in any way. The proposed scale of this development would surely be in contradiction of those statements.

The garage / store was given permission on the basis that it should be used only for purposes incidental to the enjoyment of the dwellinghouse as such and shall not be used as primary living accommodation or for any trade, industry, business or other use whatsoever.

Reason: To protect the amenities of nearby residents and to comply with Policy G3 of the South Northamptonshire Local Plan.

A restrictive planning condition was placed on the garage stating it should only be used for the purpose incidental to the enjoyment of the exisiting dwelling house and not used as primary living accommodation. To now convert the garage into a substantial dwelling would abrogate the restriction imposed by South Northamptonshire Council

The size and scale will dwarf all other houses if passed and would make a complete mockery of the Planning Laws. The design has the appearance of a disparate collection of garages masquerading as a dwelling and will be another gated suburban dwelling in a space which needs to remain green.

There has been a request by Highways to further remove more of the verge in order to offer a wider vision splay. This is totally unacceptable in this rural lane which has already been severely mutilated due to building works.
