Two members of the public attended the virtual meeting including District Councillor Mrs Barnes.

Mrs Barnes commented on the forthcoming elections in 2021 and said the procedure would be influenced by Covid –19. The Clinical Commissioning Group had awarded Paulerspury surgery £91,000 to provide another consulting room.

A draft response had been drawn up by the clerk. Councillors would consider making any amendments at the meeting to be held on 29 December 2020.

#### c) Response received from South Northants Council regarding S106 concerns.

A letter had been sent to both the Chief Executive of South Northants Council Mr Ellis and Mr Dallyn, Chairman of the Planning Committee seeking details of the decision making process which resulted in provision and maintenance of off-site open space and recreation facilities. contribution towards off-site provision and maintenance of amenity green space, natural and semi-natural green space, children's play and provision for young people and allotments via s106 Agreements without consulting the Parish Council.

Given that the parish had a sufficiency of these items a request had been made that the funds be made available to the Village Hall for maintenance (specifically roof repairs) – recreation being an activity undertaken in the village hall. Also that senior citizens were not being considered with regards to the requirement of many for a village hall in order to undertake recreation, be that physical or mental.

In the absence of answers to these questions and the commitment expressed in the Stronger Communities Strategy Consultation. Engagement: that SNC would - work closely with Parish Councils and ensure an effective, two-way communication between local government, community organisations and residents - protect and improve village halls, a further letter seeking answers would be sent to Mr Ellis and Mr Dallyn.
