Mrs Barnes commented on the forthcoming Census - 21 March 2021. This would be a form completed in the main on line for the first time. The first budget of the new West Northamptonshire Council had been approved. The maximum rise permitted of 4.99% had been resolved of which 3% would be devoted to Social Care leaving 1.9% of the increase to cover the remaining outgoings. Additional money would be allocated for those leaving care aged 18 years. The Constitution remained to be addressed.
