Residents of Heathencote had brought this to the attention of the Parish Council.

Application to vary a premises licence under section 34 of the Licensing Act 2003.

This application was to increase the permitted numbers allowed on site up to 9999. To add off-sales to the existing Premises Licence when the site hosted Christmas/Easter/Farm Markets and similar throughout the year.

It was resolved that a response would be sent to the Licensing Department.

The greyhound meets had been much busier with the trials for the Derby taking place and the traffic on Saturday night was much greater. Given that the main entrance to this venue was situated off the recently created roundabout this should be the designated entry point for traffic in future for this business.

It was not envisaged that this minor road through the hamlet of Heathencote would be required to take such a volume of traffic as this application would sanction if approved. The residents were subjected to heavy traffic into the early hours given the site closes at 2am..Also litter levels along the road side after events were extremely high which was a further annoyance to the residents.

The noise from dogs barking at certain times during the day was another concern for residents along with those heard during the events - fighting and screaming from the rear of the stables.

# 78/06/21 MRS KAREN WHEELER, MANAGER OF THE TOWCESTER MEDICAL CENTRE.

An update on Towcester Medical Centre and Paulerspury Surgery.

Mrs Wheeler said that face to face appointments with doctors had now resumed. Monthly phone calls to the surgery during the Covid epidemic had increased (Feb 2020 – 4156 calls , Feb 2021- 7973 calls). This was due to an elevated level of anxiety amongst patients, an increased demand for Primary Care Services due to the

shortage of them in hospitals, an increase in pain management demand and provision

of the Covid vaccinations. The new housing developments in Towcester had seen a rise of 402 additional patients.

When the extension to the existing surgery at Towcester was completed there would be more staff at all levels. Work to be completed by the first quarter 2022. Additional services would be available – return from hospital clinics, ENT, and community based

services.
