b) S/2020/1505/MAF Manor Farm Green Energy, Manor Farm, Grafton Road, Alderton

<u>Variation to conditions 1 (plans) and 18 (feeding regime) of S/2016/1727/MAF to increase throughput, allow additional feedstock to come from other farms, allow liquid digestate to be removed via the highway and to modify the cover to the surface water and digestate lagoon and timing of its installation.</u>

<u>Change to description and amended technical reports (noise; odour; transport statement; supporting statement; responses to EA comments, LLFA comments and Agricultural Consultant comments.</u>

Paulerspury Parish Council continues to OBJECT to Application S/2020/1505/MAF on the following grounds.

The original plan stated that there would be no need to increase the size of the clamps which hold the biomaterial. Paulerspury Parish Council has concerns that, having underestimated their requirements in the past by some 16,000 tons, these new projections may not be reliable as being final long term.

Vehicles destined for the biomass are currently passing through Alderton village despite regulations and agreements demanding otherwise. This is detrimental to the residents of Alderton. A vehicle tracking system should be in place to monitor traffic direction.

The roadside edges on the approach to the biomass from the A5 are crumbling. Any increase in heavy vehicle traffic to serve the biomass will no doubt accelerate this deterioration. Should the application be approved then there should be a requirement to improve this infrastructure.

Certainly access from the A5 at the Paulerspury junction is a further cause for concern in as much as traffic would be held up by these necessarily large vehicles whilst they decelerate prior to negotiating the tight turn.

c) To consider the lighting scheme for land to the rear of Grays Lane.

The contractors would be asked to install lighting which matched the current parish scheme.
