21 members of the public attended the meeting including councillor Mr Barter.

150/11/21 PLANNING MATTERS

a) <u>Councillors William Barter, Ian McCord and Ken Pritchard to discuss the options for</u> an increase of 10,500 new dwellings in our Ward and the effects if successful.

In addressing the meeting Mr Barter gave a comprehensive overview of the above proposals. This was a long term plan which envisaged the housing needs up to 2050. It was deemed that 68,000 would need to be built of which 30,000 still needed to be allocated. The proposal that one third of the requirement should be provided within the Deanshanger Ward (4,500 south of Towcester and 6000 north of Old Stratford) was felt unjust. Also, 58 hectares would be required for

employment.

Due to the bottleneck caused by the Old Stratford roundabout transport issues would be a major obstacle to any sizeable development linking to the A5.

In order to meet future housing needs then the alternative would be to spread development throughout the villages.

Alongside transport further issues such as education provision, health centres, protection of heritage assets (Towcester Racecourse) and the environment would need consideration and that infrastructure should be in place sooner in future rather than later which is the current practice.

Timescale:

Close of consultation – 24 December 2021 Mid 2022 preferred options identified. Spring 2023 draft plan submitted to be followed by a Public Enquiry Autumn 2023 Adoption

Details of how to comment on the proposals would be advertised via the websites and posters throughout the parish.
