05/01/22 MEMBERS OF THE PUBLIC AND PRESS

Comments are welcome from those attending the meeting. The total time allowed for this item is 15 minutes with a maximum of 3 minutes per speaker. Further public comment during the meeting is permissible only at the invitation of the Chairman.

Five members of the public were present including District Council Mr Barter. Mr Barter had given the Paulerspury Beavers, Cubs, and Scouts Group some funds from his Councillors £2,500 Covid Recovery Fund. Councillors were asked for further suggestions of worthy recipients.

Two members of the public sought support for their opposition campaign regarding the current proliferation of applications for major warehousing distribution and industrial units in and around Towcester. Each application was being considered in isolation so the combined effect was not evidenced. A transport modelling scheme taking into account the cumulative effect of all the applications with regards to the number of HGVs in particular would have shown how these applications when combined would show the true level of traffic increase and subsequent rise in pollution levels.

Warehouses in the area were already transporting workers from as far away as Derby and Glasgow thus demonstrating that there was no local employment available for such businesses. Levels of noise and light pollution would rise consequentially. There would be little benefit to the local economy.

Determination as to whether prior approval is required (under Class A, Part 1 of the above Order) in respect of the impact on the amenity of any adjoining premises of a proposed single storey rear extension extending 5m beyond the rear wall of the original dwelling house, maximum height of 3m and height of eaves 3m

b) WNS/2021/2154FUL and WNS/2021/2155/LBC. Mr and Mrs Mark and Justine Gill Briary Cottage, 8 Lumber Lane, Paulerspury

Proposed conversion of stone barn with glazed link to new dwelling with proposed new access.

Paulerspury Parish Council OBJECTED to the above applications.

The materials proposed were not appropriate to the locality and therefore contravene Policy SS2 of the South Northamptonshire Local Plan and Government guidance contained within the National Planning Policy Framework.

Paulerspury Village Design Statement (PVDS) stated that development should be carried out so that it was in harmony with its setting and contributed to and, where possible, enhanced the local environment. Development should be resisted where it made no attempt to blend with the existing environment.

Replacing the existing limestone with eternit corrugated roof sheet - Profile 6 - Black for the walls and roof would be totally alien in this location. Our VDS asked for buff/grey limestone, buff or mellow red brickwork and that the use of strong dark colour should be avoided. The Parish Council continues to wholly support that view. This is particularly important given that it was within the curtilage of a Listed Building.

Concern was also expressed at the additional traffic a business would create on this very narrow residential lane. This could lead to vehicles parking on the lane which would be unacceptable

c) <u>To consider a response to the planning applications for DHL, Woolgrowers and</u> Podium Park warehouse developments.

The Parish Council resolved to write to Ms.Anna Earnshaw, Chief Executive of West Northamptonshire Council and Mr Stuart Timmiss, Executive Director of Place, Economy and Environment at West Northamptonshire Council

19 houses built with this very dark brick would not be in keeping with the adjacent houses on Grays Close. The bricks used there were Shires Blend - Application S/2015/1209/COND - a more traditional style brick which we would ask to be used for these houses.
