Mr Barter reported that West Northamptonshire Council had agreed the budget for 2024-5 at £419.4m. Council Tax would rise by 4.99%. Risks to the budget were the financial requirements of the Childrens' Trust which were subject to needs. Since the formation of the Unitary authority the total of the economies of scale had reached approximately £90m.

b) <u>Letter received from Shepherd and Co Solicitors on behalf of Mr and Mrs Hosken, The Mayflowers, Plumpton End reserving the right to take legal action against the Parish Council citing – The Act: The Highways Act 1980.</u>

The letter had been forwarded to the Parish Council's insurer. CEO of Northamptonshire County Association of Local Councils Mr Moody had confirmed the council bore no responsibility for the ash tree on unregistered land. Council was also guided by the Local Audit and Accountability Act 2014, Sch. 8 para 1(1).

c) <u>To consider supporting a shrub planting scheme on Scriveners Lane</u> verge

The Parish Council referred the applicant to the Local Highways Authority.

No suitable areas could be found to implement this scheme.
